VACANCIES & RESERVATION

Details of number of vacancies and reservation shall be indicated in the notification to be published on our website before commencement of Online Registration. However, reservation shall be provided to OBC(NCL)/EWS/SC/ST/PwD candidates depending on the number of vacancies and as per Govt. of India Directives.

ELIGIBILITY CRITERIA

a. Valid Score in the GATE 2020

Candidate should have appeared in the corresponding paper of GATE 2020 as shown in the following table and Qualified in the same. The qualifying marks shall be as declared by GATE 2020 Organizing Body.

Final Year / Semester students who expect their final results by 14.08.2020 are also eligible to apply, provided they have obtained 70% marks or equivalent CGPA in aggregate of all semesters/years up to pre-final examination. In case of selection, their candidature shall be subject to their securing minimum 70% marks in essential qualification.

Such candidates need to mention their marks up to pre-final examination while filling up the online application form for POWERGRID.

RELAXATIONS AND CONCESSIONS

1. The posts are identified suitable for the following subcategories of PwD:
 - i. Deaf & Hard of Hearing
 - ii. Orthopedically Handicap - One Leg/ One Arm, Dwarfism. Also includes Acid Attack victims and Leprosy Cured persons with the above disabilities
 - iii. Combinations of (i) and (ii) above
2. Reservation/ relaxation/ concession to OBC (NCL)/ SC/ ST/ PwD/ Ex – SM/ J&K Domiciled/ Victims of riots shall be as per Government of India directives.
3. Persons suffering from not less than 40% of the relevant disability shall only be eligible for the benefit for PwD.
4. Relaxation in Marks in essential qualification for SC/ST/PwD candidates:
Qualifying Marks in essential qualification is relaxed to pass marks **for posts reserved for the respective category/PwD Subcategory** as per the final detailed advertisement to be issued before commencement of online registration.
5. Relaxation in Upper Age Limit:
 - a) For OBC(NCL) candidates : 3 years (for posts reserved for the respective category)
 - b) For SC/ST candidates : 5 years (for posts reserved for the respective category)
 - c) For PwD candidates : 10 years over and above category relaxation
 - d) J&K Domicile / Ex-Servicemen/ Victims of riots : As per Govt. of India directives
6. **Reservation/ Relaxation / Concession for SC / ST** will be subject to submission of relevant Caste Certificate in the prescribed format issued by a competent authority at time of application and interview, if called for.

7. **Relaxation / Concession for J&K Domiciled / Ex-Servicemen/ Victims of riots** will be subject to submission of relevant Age relaxation cum Domicile certificate /Discharge certificate etc. in the prescribed format issued by a competent authority at time of application and interview, if called for.
8. **Reservation and Relaxation for OBC (NCL)** will be subject to submission of a copy of the latest OBC (NCL) certificate in the format prescribed by the Govt. of India for “Appointment to posts under Govt. of India” from a competent authority at the time of application and interview, if called for.
9. **Reservation and Relaxation for EWS** will be subject to submission of a copy of the latest Income and Asset Certificate issued by a Competent Authority at time of application and interview, if called for.
10. **Reservation / Relaxation / Concession for Persons with Disability** is subject to submission of medical certificate in prescribed format in support of disability issued by the Government Medical Board at the time of application and interview, if called for.
11. Candidates working in POWERGRID are advised to refer to internal circular before filling up the application.
12. Relaxation/ Concession for POWERGRID Departmental Candidates
 - No Upper Age Limit
 - Qualifying Marks in essential qualification is relaxed to 50% for General and OBC (NCL) Category.
 - Departmental Candidates shall also be required to qualify in the corresponding paper of GATE 2020.
 - No application fee for applying in POWERGRID

Trainees working in POWERGRID shall not be considered as Departmental Candidate. Please refer to Internal Circular before filling up the application for further details.

SELECTION PROCESS

The Selection Process consists of marks obtained (out of 100) in the corresponding paper of **GATE 2020**, Group Discussion & Personal Interview.

Eligible candidates will have to appear for the **corresponding paper of GATE 2020**, i.e. **Electrical Engineering (EE)**

Candidates qualified in corresponding paper of GATE 2020 shall only be eligible to be considered for the next stage of selection. Qualifying marks in GATE 2020 shall be as decided by GATE 2020 conducting authority.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their **normalized marks out of 100** in GATE 2020, in the corresponding paper.

Candidates shall obtain information about their status through their login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.

Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.

Candidates must qualify in the Personal Interview in order to be considered for empanelment. The qualifying % in interview for different categories are as mentioned below:

Empanelment of Candidates

Candidates shortlisted for GD and interview may have to undergo psychometric assessment results of which shall be used as an input during the interview. Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment. Therefore it is again reiterated that candidates will have to qualify in GATE 2020 and in Personal Interview separately in order to be considered eligible for empanelment.

Please note that only GATE 2020 score (Normalized Marks out of 100) is valid for this recruitment process. GATE score of 2019 or prior is not valid.

The offer of appointment shall be issued to the suitable candidates in the order of category wise merit and based on the requirement. Selected candidates shall be notified through their login in Online application system.

Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per [POWERGRID Norms and Standards of Medical Fitness](#).

Candidates have to register themselves online at POWERGRID website with details of their **GATE 2020 Application No., GATE 2020 Registration Number and other required information, which will be made available at CAREER section of www.powergridindia.com**.
5. SC/ST/PwD/ Ex-SM/ Departmental candidates are exempted from payment of application fees. You are required to login to your candidate login section and then deposit **non-refundable application fees of Rs. 500/-** through online mode only. On submission of application fees, your application process will be treated as complete.
6. Candidates will be required to retain their GATE 2020 Admit card and GATE 2020 Score card for verification at the time of GD/ Interview / Joining in POWERGRID.

4. Vacancies are for requirement all over the country, mostly on [site locations](#). Selected candidates shall be posted for OJT and final postings accordingly.
5. Management reserves the right to cancel / restrict /enlarge / modify / alter the recruitment/ selection process, if need so arises, without issuing any further notice or assigning any reason thereafter.
6. Date of issuance of final mark sheet shall be taken as the date of acquiring qualification.
7. Wherever CGPA/OGPA/DGPA or Letter Grade in a degree / diploma is awarded, its equivalent percentage of marks must be indicated in the application form as per norms adopted by University / Institute.

- Percentage of marks obtained by the candidate in the bachelor's degree shall be calculated based on the practice followed by the university/institution from where the candidate has obtained the degree. In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks shall be based on the procedure certified by the university/ institution from where they have obtained the bachelor's degree.

In case the university/ institution does not have any scheme for converting CGPA into equivalent marks, the equivalence would be established by dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100.
